### **New Business:**

## 303 Possinger Drive – Edgemont Terrace, LLC -Sketch Plan

A Master Sketch Plan was submitted and received by Edgemont Terrace LLC, a party interested in purchasing a parcel of property currently owned by BCM International Inc.; locally known as Streamside Camp and Conference Center. The property is zoned Industrial.

Engineer and business owner, Tony Ganguzza and Jerry Fasnacht, were present to discuss the submitted sketch plans. The sketch plan outlines a proposed development plan of two warehouse facilities to be constructed. One warehouse is proposed to be 345,000 sq. ft and the second warehouse to be 400,000 sq. ft. Warehouses are a permitted use in the Industrial Zoning district.

A review dated June 16, 2022 from Township Engineer Sal Caiazzo, Hanover Engineering, was discussed. Items of concern brought up by the members of the Planning Commission included:

- Truck traffic Route 715, Possinger Road, sight distance at the Rt. 715/Possinger Road intersection
- Stormwater/wetland buffers MCCD
- Septic relocation could be challenging should it be necessary

- Exceptional Value Wetlands
- Stormwater run off
- Residents living on Possinger Road, Route 715 Noise, traffic, stormwater run off

Edgemont Terrace LLC stated they will reach out to PennDOT regarding the truck traffic/sight distances, etc. After Edgemont Terrace LLC completes contacting involved entities, they will contact us if they intend to move forward with the project.
