Notifications - Email

- Prerequisite
 - Custom domain name
 - To send from customer's verified domain
 - Important part of the branding
 - For authenticity
 - Domain + logo + background color
- Email preview tool
 - Template tests concluded
 - Cancelled 7-day trial to avoid charges

Notifications - Text

- Free test phone #
 - Send to numbers registered at MailerSend
 - Daily limits
- Purchased phone #
 - \$2 / month
 - Toll-free 833-221-7705
 - Shared between all notifications customers
 - Allows up to 1000 texts sent per day
 - Verification process available to remove limit
- Advantages
 - Nearly 100% delivery & 98% open rate (email 20-30%)
 - Sent & received in seconds, majority read in first 5 minutes
 - Not Internet dependent

Notifications - Compliance

- CTIA consent categories
 - Conversational
 - Respond to user's request
 - Consent implied
 - Informational
 - Notifications should remain in this category
 - Express consent
 - Promotional
 - Express written consent (more restricted)
- T-Mobile non-compliant traffic fees
 - For app to person senders
 - Began Jan 1, 2024
 - \$2000 social engineering (such as phishing)
 - \$1000 illegal content
 - \$500 all other violations








Payments

- API token and caching completed
- Enrollment tool completed
- Integration into paynow processing flow
 - Originally developed for OPO using Stripe
 - Adapted for Registrations with payment disabled
 - Adding option to pay through JustiFi
 - 3 paths
 - (Original) Stripe – for OPO Startups
 - (Recent) Free – current reservations
 - (New) JustiFi – for Munibit websites
 - Resulting code can be reused elsewhere
 - Only cards in reservations
 - Not feasible to hold for ACH
 - Simplifies first development
