#### ROLL CALL OF ATTENDANCE:

Mayor Zappariello opened the meeting by asking Engineer Robert Smith to give updates of any current issues. Engineer Smith provided updates on drainage meetings held with the NJ Department of Transportation (DOT) and Road Supervisor Bill Nimohay.

## PUBLIC PORTION:

Mayor Zappariello invited the public to speak and announced that a meeting will be held to discuss concerns involving the Landisville Volunteer Fire Department.

Brian Fatcher, Kimberly Lane questioned items on the agenda. Mayor Zappariello responded that he or the CFO would contact him for clarification.

Loretta Gazzara from the Landisville section of the Borough and Commissioner of Fire District #1 broke down the fire company's average monthly cost to the taxpayer. Commissioner Gazzara then addressed Mayor Zappariello refuting statements and corresponding dates made by him at prior meetings. Ms. Gazzara also concluded that mere attendance at a meeting of the fire commissioners does not constitute supporting the department.

Susan Romeo from the Landisville section of the Borough stated she was recently made aware that Mayor Zappariello, acting as an agent of the Borough of Buena, was circulating a petition and obtaining signatures in support of closing the Landisville Fire Department. Ms. Romeo further suggested that residents were misled by the mayor which resulted in the signing of the petition. Ms. Romeo clarified that no fines were incurred as a result of the violations because of the abatement period. Ms. Romeo encouraged residents who may have signed the petition under false pretenses to request their name be removed by emailing or mailing a letter to Mayor Zappariello. Ms. Romeo encouraged Councilman D'Alessandro to communicate with the Atlantic County Office of Emergency Management, and all members of the governing body to meet and communicate with members and volunteers of the Landisville Fire Department.

Keith Kemery, Consultant for the Landisville Fire Company, provided a detailed accounting of steps taken to address auditor recommendations and violations. Mr. Kemery stated that Department of Labor violations have been addressed and gave an update on Department of Health violations. Mr. Kemery requested a meeting between the Landisville Fire Company and members of the governing body to work cooperatively in addressing the matters.

Betty Testa from the Landisville section of the Borough of Buena encouraged members of council to consider the humane aspect of their choices and to make independent decisions when voting.

Antonio Vicidomini of Harding Highway addressed his concerns over the lack of communication from the governing body.

Mayor Zappariello thanked the public and stated that a in-person meeting will be held to address any unanswered questions.

#### Councilman Mancuso joined the meeting.

**WHEREAS**, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

**WHEREAS**, <u>N.J.S.A.</u> 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

**WHEREAS**, the Borough Council of the Borough of Buena in the County of Atlantic finds it advisable and necessary to increase its CY 2021 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

**WHEREAS**, the Borough Council hereby determines that a 1.0% increase in the budget for said year, amounting to \$64,427.13 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

**WHEREAS** the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

**NOW THEREFORE BE IT ORDAINED**, by the Borough Council of the Borough of Buena, in the County of Atlantic, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2021 budget year, the final appropriations of the Borough of Buena shall, in accordance with this ordinance and <u>N.J.S.A</u>. 40A: 4-45.14, be increased by 3.5 %, amounting to \$90,197.97, and that the CY 2021 municipal budget for the Borough of Buena be approved and adopted in accordance with this ordinance; and,

**BE IT FURTHER ORDAINED,** that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,
