Public Safety Report of 09.27.2021

Since dissolution, Fire District #2 has:

Accessed Arbor Ave property on 7.29.2021, escorted by several Franklin Township police officers.

- Upon a comprehensive inspection of the property, items of concern were noted. Secured open gas valves and adjusted temperatures within building to conserve energy for an unoccupied space.

 Over the next few days, Fire District #2 was successful in changing the locks on the building, transferring ownership of financial accounts, and spent countless hours reviewing paper and computer files to determine the scope of this transition. We continue to have a weekly presence performing tasks needed to maintain the property. Next, we intend to procure estimates to address the many leaks within the roofing system.
- "We noted four (4) 800 MHz portables on the counters. Inventory of serial numbers were recorded. After contacting the Gloucester County

 Communications Center, they stated that former Fire District #1 had five (5) portable radios registered to them within the Gloucester

 County system; with each one having its own ID number. One portable was discovered to be missing from the building and has since

 been reported to the police and entered into the NCIC system as a lost/stolen item. _ Filing cabinets, known to be existing from former

members, were removed from the office (three filing cabinets) prior to our arrival. These filing cabinets, reportedly include all personnel files, training records of members, vehicle service files, etc, are missing. Landisville Volunteer Fire

Company has acknowledged the missing files are in their possession.

Inspection of the filing cabinet in the former Commissioners office revealed titles for three of the vehicles listed as vehicles/assets of the former Fire District #1. Titles for the Mini-Attack and Tender cannot be located as they have either been removed or destroyed.

Fire District #2 received correspondence that indicated the titles were stored in the safe. We were not provided with the combination at that time. Fire District #2 again requested the combination which was received days later with no directions of how to use the combination to access the contents. With the assistance of a locksmith, we were able to finally gain access, only to discover the safe was empty.

We have been approached by several former members who are requesting their personnel files. Our response has been consistent that we cannot provide something we have no access to. Also of note, any progress on the disposition of the apparatus has been delayed due to oil samples taken and analyzed showing service neglect and a lack of maintenance on two of the apparatus. We will be sending one of the apparatus to Delaware for further review and evaluation.

- Dpon our initial tour, it was noted that the antique bell on the exterior sign was missing and apparently stolen. We also noted the precast panels were witnessing water damage and previous repairs were susceptible to additional damage. A decision was made to remove the historic precast panels as soon as possible to conserve their integrity and avoid further vandalism. Discussions internally are in favor of donating the sign to the Owner of the original Fire House on Nixon St. for reinstallation at its former home. If the owner does not want the sign, we intend to donate it to the historic society of Buena Borough. Over the weekend of September 18th and 19th, there was quite a public uproar on Social Media based on assumptions and misinformation. We received verbal threats from bystanders instigated by the social media frenzy, during the time while we volunteered on preserving their historical item.
- LUpon our initial inspection of the building, it was noted that the Antique Fire truck was missing upon our entering the building. After weeks of research, it was discovered that the former Fire District had listed this as an asset (vehicle) of the former Fire District for the past 6 years of their DCA budget submission. We have also discovered that the former Fire District #1 has paid for repairs and insurance costs over the past many years; most recently the current insurance policy was paid from the Commissioners general checking account. Based upon the use of taxpayer funds to furnish, maintain, and insure, this clearly establishes that the Autocar, is property of Fire District #2, not the Landisville Volunteer Fire Company.
- LUpon receiving the signed Ordinance, it was delivered to the Landisville Post Office to gain access to the Post Office Box to retrieve any invoices due to their creditors. We initially received a key to access the box and originally retrieved some utility invoices and some other correspondence. A few days later, Landisville Fire Company member Ken Barbagli, confronted the Postmaster and demanded that access be restricted to only the Landisville Volunteer Fire Company. To calm the situation, the Postmaster agreed and informed us we will no longer have access. We have no reliable means to retrieve future invoices to ensure timely payment. We have been

 $unsuccessful\ in\ transferring\ some\ utility\ accounts\ to\ our\ name\ and\ mailing\ address.\ The\ Utility\ companies\ are\ he sitant\ about\ doing$

this without disconnecting service. There is documentation that clearly delineates that the Post Office box rent was paid for with

Commissioners funds of the former Fire District #1. Here again, if the Post Office box is in fact the property of the members of

Landisville Volunteer Fire Company; why in fact did the Commissioners of the former Fire District #1 pay the Post Office box rent

with taxpayer money? Which is it, misappropriation of taxpayer funds or the Commissioners of former Fire District #1 property? It

appears that they would like to have it both ways.

- Several former members have begun to request withdraw of their LOSAP funds since the Fire

District is now officially dissolved. We have been consistent with our response to all members. Without access to membership rosters,

personnel files, related documentation and previous yearly run sheets that would allow our Commissioners to accurately verify the

members meeting their

LOSAP point eligibility, we cannot complete a verification audit.

We will continue to evaluate and incorporate the assets and property of former Fire District #1 and completing the transition of the expanded Fire

District #2. We anticipate the full transition of all items within the next 12 — 18 months. This timetable is fluid and dynamic and may extend

beyond the 18-months if we continue to receive fragmented information.
