He stated he hopes to see improvements and talked about a stop sign with graffiti on it. Talked about new signs are needed in the borough and at the fire department. Joe brought up houses on Whitaker with cars up on blocks and parked in the middle of the yards. Rich stated he took care of the car. Joe also stated there is a residence on Dora that has waist high grass, did not know the address. Rich said he would go over and take a look.

Lori Urban - 271 Washington Avenue - inquired about the poison ivy at the garage on pine street. Wanted the borough to take care of it, council advised no the borough cannot spray private property and if they started they would then have to do it for all of the borough when it is the resident's responsibility.
