Manager's Message

I am thrilled to be writing my first message as Borough Manager in the inaugural edition of Crafton's fully redesigned newsletter! It's been an honor to serve the community for the last several months, and I look forward to providing many more updates in future newsletters about all the exciting things happening in Crafton.

Bringing back the quarterly newsletter is just one of many ways the borough is improving access to and communication with your local government. In 2018 Crafton's Borough Council initiated a website re-launch, which has enabled administrative staff to make changes to the website in-house, and contracted with the Savvy Citizen mobile app to provide residents with quick, convenient updates about community events, construction alerts, and other important public notices. If you can't find the information you need online, don't be afraid to email us or pick up the phone! The Borough Administrative Office is here to be your connection to your local government.

As we prepare for the rest of the year, I wanted to share some of the borough's major projects and goals for 2019:

- **Community Revitalization** In my many conversations with residents, business owners, and other local stakeholders, I've heard loud and clear that Crafton is a community with a lot of hometown pride. To make sure that Crafton has much to be proud of for years to come, we'll be initiating a comprehensive review of our property maintenance, land use and zoning regulations to encourage sustainable care of our existing homes and businesses, and thoughtful, responsible redevelopment of properties that provide opportunities for community and economic growth.
- **Bringing Back Main Street** Crafton is a hidden gem in the Pittsburgh region with a highly walkable core business district and easy access to the West Busway. With sidewalks and storefronts, a little curb appeal goes a long way! This year we'll be exploring design ideas for "streetscaping and place-making" renewing our pedestrian infrastructure by repairing the existing sidewalks, establishing wayfinding features like community entryway signs and decorative street poles and banners, and supporting our local business core in engaging the community.
- **Infrastructure Improvement and Restoration** As a community with a combined sanitary-stormwater sewer system and streets that come in lots of different materials and sizes, ensuring the long-term health of our infrastructure is extremely important. We'll be working with the borough engineers to develop repair plans for significant structural issues in our sewer lines and roadways, and pursuing grant funding for solutions to reduce peak flow during major rain events.
 - The administrative office has also started to track flooding incidents directly reported to us by residents in an effort to identify consistent problem areas in need of infrastructure improvements.
- Code Enforcement The Borough Council made increased and consistent code enforcement activity a major priority in 2018. We're here to work with property owners to find solutions that keep the community beautiful, clean and safe. Administrative and code enforcement staff are in the process of compiling a list of community resources for those who may need help maintaining their property keep an eye on our website for more details soon! If you have questions or concerns about Crafton's property maintenance requirements, please don't hesitate to contact the code enforcement office at 412-921-0752 ext. 26.

This list is only a brief picture of the vision set out in the 2017 comprehensive plan update, Crafton-Ingram Thrive. Your elected officials and borough staff are committed to continuing to develop creative solutions to the many challenges that municipalities will face in the coming years. Code Enforcement Memo

When a person buys a property in Western PA a few things are generally assumed. Firstly, at some point in time there will be a bunch of consecutive cloudy days that are a little depressing. Secondly, flying a flag other than a Steelers flag in the fall will most-likely be seriously frowned upon by neighbors. Thirdly, summer will not feel long enough but Autumn will be beautiful. And lastly, dealing with snow and ice will be unavoidable. Here in Crafton these things are no different. We are currently in the throes of another Western PA winter. This means waking up to remove ice and snow from your car or sidewalk, getting your kids to school maybe, and then yourself to work by car or busway. I'd like to focus on the snow removal for a second because lately I have been dealing with it daily as have all of the residents of Crafton.

Buying a house in Western PA, and specifically in Crafton Borough, means homeowners and to a certain degree tenants, are bound by the code here. When it snows, according to the code, "It shall be unlawful to allow ice, snow or debris to remain on the sidewalk longer than 24 hours after its accumulation." (Chapter 193-42 B) So we all have about 24 hours after the snow or ice storm stops to clear the sidewalk. I have been out in the Borough and what I have seen so far this year is a lot of ideas about what "clearing the sidewalk" means. The code says allowing any of it-ice, snow, debris—is unlawful. I have seen sidewalks completely untouched, sidewalks salted but not shoveled, and shoveled and not salted. None of those options are really safe for pedestrians. Salting snow makes touch points to walk but not a clean ice free surface, unshoveled snow is tramped down and turns into dangerous ice, and shoveling without salt makes for a nice smooth icy surface. Sidewalks that are hazardous or have this remaining debris can be cited.

In order to comply and make your sidewalk safe it is best practice, so to speak, to shovel and then salt/melt the ice and snow. That generally clears everything. And since it is Western PA, it might have to be done multiple times a week until the weather breaks. Many residents live on streets with very busy sidewalks that are used by kids to get to their bus stop or to school. Or perhaps their sidewalk is a part of someone's walk to work or the busway or to a business. This is a heavily walked community by all of us. It is very important to keep sidewalks clear so that no one is injured— I have already received multiple slip complaints—so we all need to do our part.

Sometime in April the weather will break and we will all get a chance to put the salt and shovels away. There will still be some cloudy days, our Steelers flags will sadly be put away still, but we will all be anticipating Memorial Day. In the meantime, please be a good neighbor and keep your sidewalk safe.

As part of my continued initiative to keep you up-to-date on the wide range of services at your disposal, I wanted to let you know about the upcoming, beneficial events my office will be hosting.

Looking for **help with employment**? If so, we have a number of resources to help you, including my **Employment Center**, which is located at my district office, 436 S. Main St, Suite 100, Pittsburgh, PA 15220. My center has a computer that allows you to access a list of employers looking to fill job vacancies. You also can quickly access information on transportation, developing a resume, tips on interviewing and much more. Job seekers can utilize my employment center weekdays during my office hours, which are 8:30 a.m. to 4:30 p.m. To schedule a one-hour time slot at the Employment Center, contact my office at 412-928-9514.

And, don't forget about my **Workshop Wednesdays**, which take place every second Wednesday of the month in my district office. Our upcoming dates include Feb. 13, March 13, April 10 and May 8. This is a great opportunity for those looking for employment! You'll have the opportunity to use the Employment Center's computer, get feedback on resumes and cover letters, learn about post-secondary education opportunities and more.

Our Workshop Wednesdays also are in partnership with Building Bridges for Business. We also are joined by staff members from PA Career Link at workshops every other month (March 13, May 8, and July 10) to assist job seekers and those having issues with unemployment. On March 13, PA Career Link will host a Job Fair Readiness workshop to prepare job seekers for upcoming job fairs. Call my office at 412-928-9514 for more details.

Speaking of job fairs, on **Thursday, March 28**, my office, in partnership with Sen. Wayne Fontana, PA Career Link and Building Bridges for Business, will host a **job fair** at St. Catherine of Siena Parish Hall in Beechview. The event will run from 4 p.m. to 7 p.m., and will feature dozens of employers who will be onhand to talk with job seekers about employment opportunities. We will also have representatives available to discuss apprenticeships and other technical training programs to help you gain information on acquiring new skills to become gainfully employed.

Aside from employment events, I wanted to let our veterans know about our **Veterans Outreach Clinics**, which are hosted by my office, in partnership with U.S. Rep. Mike Doyle and the Veterans Leadership Program of Western PA. These outreach clinics take place every third Friday of the month (Jan. 18, Feb. 15, March 15, and April 19) from 10 a.m. to 2 p.m. Veterans AND their families are invited to these events.

I also want to remind our seniors about the **monthly senior information sessions** I host at senior centers across the district. Each month features new topics dealing with programs and services available to you. I frequently have special guests lined up for sessions. February will feature a special guest from the Area Agency on Aging to talk about available services through their network. We also have sessions lined up with the Port Authority of Allegheny County to talk about senior transportation services, including Access and OPT. **If interested, call my office for dates and locations**.

Lastly, I wanted to remind residents about the **free**, **upcoming SHRED EVENT** at Crafton Park on **Saturday**, **May 4**. This event, hosted by my office and in partnership with Sen. Wayne Fontana and Crafton Borough, will run from **8 a.m. to 11 a.m. – or until the shred trucks are full!**

Spring is approaching and we will see a lot of familiar outdoor activities returning to Crafton. Unfortunately, the arrival of warmer weather usually brings with it a rise in criminal activity. Burglars, thieves and vandals all prefer the warmer months to practice their activities. Residents are reminded to keep their homes and vehicles locked at all times. So far this fall/winter time, we have experienced numerous thefts from vehicles. In almost every case, the cars were left unlocked and items of interest to the thief were left in plain sight. This is a combination that is almost too good to pass up. Crafton is a safe community but we should make every effort to deter criminal activity by taking basic precautions to prevent crime.

Scams

Phone and mail scams are becoming more common, elaborate, and harder to detect. Unsolicited phone calls could be an attempt to obtain your personal and financial information. Do not provide any personal or financial information to anybody that calls you. A very common phone scam is the IRS phone scam. Thieves call taxpayers claiming to be IRS officials. They demand that the victim pay a bogus tax bill. They con the victim into sending cash, usually through a prepaid debit card or wire transfer. Here are several tips, taken directly from IRS.gov, to help you avoid being a victim of these scams:

The IRS will not:

Call you to demand immediate payment. The IRS will not call you if you owe taxes without first sending you a bill in the mail. Demand that you pay taxes and not allow you to question or appeal the amount you owe. Require that you pay your taxes a certain way. For instance, require that you pay with a prepaid debit card. Ask for your credit or debit card numbers over the phone. Threaten to bring in police or other agencies to arrest you for not paying.

The members of the Crafton Volunteer Fire Department are volunteers; but more importantly, they are our friends, neighbors and family. They give their time freely and generously to protect you and those you love. They are on call 24 hours a day, 365 days a year. They are continuously upgrading their skills and knowledge of fire-fighting by attending training sessions and practices in the evenings and weekends. They protect your most valuable possessions ... yourself, your family and your home. How much is that worth? Your donation to the Crafton Volunteer Fire Department is fully tax deductible and your support is appreciated and needed. 2018 was an extremely busy year for the fire department. We responded to a total of 341 incidents. 28 of these were assisting EMS on medical calls. That leaves a balance of 313 fire related responses. In our first due area of Crafton, Rosslyn Farms, and Thornburg there was a total of 178 calls. 25 of these were in Rosslyn Farms and

another 9 were in Thornburg. We also responded to 135 requests for mutual aid service to our surrounding communities. Of these calls, 19 were building fires to varying degrees of severity, but over a dozen of them being major multi company incidents. We would like to thank everyone that makes these statistics possible. We could not do it without the public's support.

2019 Trash Collection Information


GENERAL INFORMATION: CONTAINERS SHOULD NOT TO EXCEED A CAPACITY OF THIRTY (30) GALLONS, SECURED WITH TIGHT LIDS. TRASH AND/OR RECYCLABLES SHOULD NOT BE PLACED AT THE CURB PRIOR TO 4:00 PM ON THE DAY PRIOR TO COLLECTION. CONTAINERS MUST BE REMOVED FROM THE COLLECTION SIGHT THE SAME DAY AS TRASH COLLECTION. TRASH CANS ARE NOT PERMITTED TO BE STORED IN THE FRONT OF THE BUILDING.

Single Stream Recycling: The following can all be placed in the same container, marked CLEARLY as "Recycle" (RCY). Aluminum/Glass food and beverage containers, natural and pigmented placed narrow-neck containers marked with symbols 1, 2, 3, 4, 5 and 7, food and beverage cartons, ferrous (iron, steel, tin) cans, **ALL FREE OF FOOD DEBRIS and LIDS REMOVED**. Newspaper, unbound – black and white or pigmented. Construction paper, craft paper, cereal boxes, shoe boxes, printer paper, computer paper, copy paper junk mail, magazines, or catalogs. CORRUGATED CARDBOARD **MUST** BE FLATTENED AND CUT TO 14 x 14 INCHES. **No plastic bags or "grocery" type bag.**

E-Waste/Hazardous Waste: Household cleaners and/or electronic waste will NOT be accepted for normal trash collection. Contact Waste Management and the representative will give you further instructions on how to dispose of these items. 1-800-449-7587

BULK WASTE: Such as, Furniture, appliances, washers, dryers and carpeting (cut, bundled and tied) in lengths no longer than 4 FT should be limited to one item per week. UNDER STATE LAW; Refrigerators, freezers, and air conditioners **MUST** have the Freon removed by a professional contractor and an evidence sticker displayed. Please limit bulk to one item per week.

NEW IN 2019!!! Recycle must be placed LOOSE in a container clearly marked recycle. Bagged recycle WILL NOT be picked up!



Property Maintenance



HIGH GRASS AND WEEDS

As established by Borough Ordinance the height of grass and weed growth is not to exceed six inches. Please maintain a clean and well kept lawn; and don't forget to trim the grass between the curb and sidewalk. Also, sweeping or blowing the grass clippings into the street is prohibited.

SNOW REMOVAL & SIDEWALK MAINTENANCE

CRAFTON BOROUGH ORDINANCE: It shall be unlawful to allow ice, snow or other debris to remain on the sidewalk longer than 24 hours after its accumulation. Also, sweeping, shoveling, or blowing snow into the street is prohibited. It is illegal to drive or park a vehicle on a sidewalk, or portion of a sidewalk. It is the responsibility of the Property Owner to maintain all sidewalk areas in a good state of repair and clear of any obstructions.

HOUSE NUMBERS

CRAFTON BOROUGH ORDINANCE: A house number must be properly posted in order to quickly and accurately identify all structures in the Borough: Numbers must be placed in a position to be plainly legible and visible from the street fronting the property, numbers shall contrast with their background, numbers shall be Arabic numerals a minimum of 4 inches high and minimum stroke width of .5 inch. If not sure, contact the Borough Offices for assistance.

SEWER BACK-UPS & STORM WATER RUN-OFF

In the event you are experiencing a sewage back-up, contact the Borough Public Works Department at 412-921-0752 ext. 16. First the Borough will check its main sewer line for any back-up problem in the area. If no back-up is detected in the main sewer line, the problem may be in your lateral (from the main line to your structure). It is your responsibility to remedy the problem and make any repairs to your lateral.

<u>Storm water run-off</u>: Drainage from roofs and gutters on the premises shall not be discharged in a manner that creates a public nuisance; it may be discharged directly into the Borough's combined sewer system. Storm water run-off must not discharge on to adjacent properties, sidewalk or street.

The following are Permits Required by Ordinance:

- Home Security/Alarm Systems
- Dumpster/Storage Containers
- Zoning Use/Occupancy Permit
- Garage/Yard Sales
- Keeping of Chickens
- Recreational Burning Permits

The following are Permits Required by Building Code:

- Fences, Sheds, and Retaining Walls
- Replacements resulting in structural changes
- Swimming Pools
- Driveways
- Interior and Exterior Renovations such as; Building, Electrical, Mechanical, and/or Plumbing

Always contact the Building Inspector to ensure you have acquired the proper permits for your project.

Residents/Landlords MUST complete the New Resident/Tenant Registration Form within 10 days of change in occupancy. Make sure your employer has the correct PSD (730402) code for Earned Income Tax Withholding.

Borough Services

TREE BRANCH/LIMB CHIPPING: Crafton Borough received a grant from the Pennsylvania Department of Environmental Protection (PaDEP) in 2011 to purchase a Woodsman 730 Wood Chipper. This equipment is used to process and facilitate the recycling of wood waste in the Borough.

Residents may request the removal and chipping of tree limbs. Requirements: Single limbs cannot be more than 5 inches in diameter and no longer than 10 feet in length, placed at the curb. Volume of materials should not exceed what would generally fit into a pick-up truck. Materials will be chipped onsite and removed or left for use by the resident.



<u>Hedge cuttings, limbs and branches</u> – PA Act 101 prohibits these materials from inclusion in the waste stream, and recommends they be composted. Do not set out with your weekly garbage, the Waste Haulers have been notified to NOT pick these items up.

LEAF COLLECTION: The Public Works crew collects and composts leaf waste generated in the Borough each year commencing on or about Oct. 1st through Dec. 1st; weather-permitting. During this time, kindly rake leaves, free of twigs, dog waste and other debris, to the curb. Please do not call the Borough offices for pick-up of leaves raked to the curb. Public Works will pick up <u>bagged</u> leaves, in eco friendly paper bags, please contact the Borough Office for pickup. Also, be aware that our leaf vacuum equipment does generate "leaf dust" which is unavoidable. Leaf dust may accumulate on parked vehicles during the operation of this equipment.
