Fire Code Ordinance – Tabled.

Bridge Loan Options- A motion was made by Jonathan Jakum, seconded by David Fink to accept the loan proposal from Neffs National Bank that will fund the Buckery Road bridge project. (The funds will pay the bridge bills in the interim until the DCED Local Share Account Statewide grant reimbursement checks process through.) Neffs Nation Bank: Loan amount: \$600,000 One Year Bridge Loan, Repayment Terms: One year draw period. Interest only monthly. Balance due in full at maturity, Interest Rate: 5.13% Tax Exempt (Township must submit Attorney opinion letter stating this is a tax exempt obligation to obtain the tax exempt rate otherwise it is a 6.49% interest rate), Estimated fees: Loan Origination - \$3,000 (1/2%), Document Prep- Township Legal Counsel, Attorney Fees – Bank Legal Counsel. Motion carried.

First Net Radio: Phone and Tablet Options – Tabled.

New Public Works Building – David Fink requested Geoff Dean gather more information for the future Wash Bay. David Fink requested a "Request for Proposals" for the new public works building.

Review Auditors Letter – The auditors provided the Board with a positive letter as a conclusion to the 2024 audit.

Pressure Washing Municipal Building - A motion was made by Jonathan Jakum, seconded by David Fink to allow a "Low Pressure" washing (brushes and detergent to prevent damage to recent repairs on the roof) of the Township owned building roofs and pressure washing of the sides of the structures located at 6272 Route 309. Motion carried.

New Business

Township Building Code Official – Tabled.

A motion was made by Jonathan Jakum, seconded by David Fink to table the request for an addition of land owned by Kelly and Earl O. Zellner Jr. totaling 54.58 +/- acres including in 2 parcels: 554126607503-1 and 554125725428-1. Motion carried.

A motion was made by David Fink, seconded by Jonathan Jakum to make the funds available for all 4 farms up for preservation (See below for estimated schedule and amounts). Motion carried.

A motion was made by Jonathan Jakum, seconded by David Fink to advertise Ordinance #2025-2 which allows an Accessory Dwelling Unit as an accessory use in all zones. (Previous Ordinance #2022-1 "accessory apartment", which was removed in error in the Zoning Amendment of 2024.) Motion carried.

Township Sign Policy – David Fink suggested adding a new content option for "humor" and limiting the number of events each non-profit can have in a month; also, a request to add a 5 week advance posting limit (prior to the date of the event or ticket sales deadline). Tabled to allow more time for consideration.

Public Comment

Jay Scheffler: Announced the government gave municipalities the ability to raise the fire tax to 10 mills without needing to go through the referendum process. Also, he suggested there be less board-time for non-profits from outside Heidelberg Township on the outdoor sign.

Correspondence

PennFuture- Re: Data Center Model Ordinance – suggested the board consider utilizing their model ordinance for Data Centers. The board declined the offer since Lowhill Township has zoning for "all other uses" Heidelberg is not required to provide for that use.
