Treasurer Debbie Lensegrav presented commissioners with an activity report including motor vehicle fees, new state software, upcoming training, delinquent property taxes, assessment freeze applications, and distress warrants.

Highway Superintendent Dwayne Heidrich provided an activity report including gravel, ditches pulled, blading, and mowing.

Beau Riopel from Butler and Heidrich provided quotes for skid steer and lowboy trailer. Currently being rented for fencing and bridges. Discussion included other uses for funds such as crushing more gravel and hiring work out to maintain more roads. The lowboy discussion involved need for an additional low boy to reduce the amount of time it takes to move equipment to job locations as one of the current ones has been in the shop most of the summer.

Motion by Herman, Second by Batterman, to approve the purchase of skid steer in the amount of \$115,439.87. Vote Unanimous. Motion Carried. Funds are available in 2024 reserve funds.

Motion by Herman, Second by Walton, to approve the purchase of lowboy trailer in the amount of \$136,001.17. Vote Unanimous. Motion Carried. Funds are available in 2024 reserve funds.

Beau Riopel from Butler and Heidrich provided payoff amount for Belly Dump Train and Side Dump Trailers.

Motion by Batterman, Second by Erk, to approve using reserve funds to pay off Belly Dump Train and Side Dump Trailer in the amount of \$102,593.80. Vote Unanimous. Motion Carried.

Beau from Butler and Heidrich provided quotes for two Walk 'n' Roll Compactors to be delivered in 2025. Motion by Herman, Second by Walton, to approve the purchase order for two Walk 'n' Roll Compactors with quick attach in the amount of \$53,780.00. Vote Unanimous. Motion Carried.

Superintendent Heidrich requested the public to cease damaging the roads that have received Mag Water treatment. The treatment is expensive, and the damage is extensive.

Deputy Sheriff March provided a monthly activity report.

Deputy Sheriff March gave an update on 2025 Homeland Security LEMPG grant with recommendation that the county does not apply for the grant due to the difficulty of meeting the requirements.

Auditor Annie Capp presented an activity report for the Auditor's Office including election activities, ballots, and effective date of 2024-02 ordinance.

Auditor Annie Capp presented quote to repair Administrative Building downstairs. \$25,000 will be received from Insurance claim. Additional quotes will be sought. Discussion was held regarding cause of issue and how to mitigate further issues.

Motion by Erk, Second by Batterman, to enter into Executive Session: Legal Counsel 1-25-2(3) at 10:46 AM. Vote Unanimous. Motion Carried. Exited Executive Session at 11:18 AM. No action was taken as a result of Executive Session.
