States Attorney LeEllen McCartney provided an activity report including open cases, number of inmates, and upcoming Grand Jury that are keeping the SA office busy. Mr. Barnaud is working part time and getting up to speed with systems and cases that are not in conflict.

Chief Deputy March presented information on computer to be surplused in Sheriff's Office. States Attorney McCartney suggested that there may be some statutory requirements to advertise item for bid.

Motion by Herman, Second by Erk to surplus computer from Sheriff's Department. Vote Unanimous. Motion Carried.

Auditor Capp provided an activity report including upcoming election activities, absentee voting stats, and attendance at SDACO Fall Convention.

Auditor Capp presented the quotes received for repairs at Administration building.

Motion by Erk, Second by Battermanto accept Ken Thomas construction bid received in the amount of \$25,988.58. Vote Unanimous. Motion Carried. Ask Mr. Thomas and ABE for a quote to paint.

Auditor Capp provided Growth and Abatement reports submitted to DOR. As of 30Sep2024 these have not been approved by DOR. Once approved levies will be calculated.

SA McCartney and Auditor Capp presented revised Butte County Handbook to commissioners for review and approval. An overview of changes was given, and discussion was held regarding a designated media spokesperson. The revised handbook will be brought back for approval 15Oct perhaps by Resolution.

Annual JJRI distribution will be \$29,250. Discussion was held regarding where to use funds, the different programs considered to be diversion programs and success of programs in Butte County.

A recess was taken at 10:45 AM. Meeting called back in session at 10:50 AM. Committee Reports included

- Walton and Ager- Ambulance meeting directors are doing a great job and need more help. Discussion was held regarding issues with water and mold in the building.
- Erk and Batterman
 – Building Committee meeting focus on getting assessment of old jail, quote on elevator at Admin building, remodel of basement, and potential of new building.
- Herman attended the SDACC convention. Presentations of interest included situational awareness, road classification, and mineral property rights.

Old Business –

- Capp –information on Fire Reversion and Grant moneys to be distributed in October.
- Discussion was held regarding appointment of planning commission opening. Planning Chair Lewis and Chief Deputy Jason March will also be on interview panel. Discussion was also held regarding whether the sitting commission or the future commission should make the appointment. Consensus was the interview panel will bring a recommendation. Commissioners will take recommendation and existing commission members will appoint.
- Auditor Capp gave an update on the HVAC upgrade.

- Herman five year building comprehensive study is out of the scope of BHCLG but there are grants available. Herman will ask about media training.
- Herman discussed the travel and conference expenses. Trainings are considered continuing education and are useful.
- Capp Educated Voter Night to be held 07Oct2024 in the Newell School, Austin Auditorium
- Chief Deputy March gave an update on two grants Homeland Security for radios and ABC Grant.
- Discussion held regarding Alert Sirens currently not working.
- Walton mentioned he plans to resign end of 2024.
