outside of meetings. Chairperson Harms suggested that public can contact their commissioner anytime outside of meetings.

Veteran Service Officer Jasen Saivong presented an activity report including disability compensation claims, spousal death, and transportation numbers. Chairman Harms asked about upcoming assistance for veterans. VSO Saivong shared some information on qualifications and will provide more information as it comes. Applicants apply thru the VA not the VSO, but Mr. Saivong will direct them to the correct contact when asked.

Motion Walton, Second Erk to approve Budget Supplements from Cash Reserves (Increase in Spending Authority for 2022). Vote Unanimous. Motion Carried

Hollie Stalder – Director of Belle Fourche Development Corporation provided an annual activity report including housing issues, discretionary formula, grant applications, Leadership Belle Fourche sessions with City and County are being rescheduled due to storm delays, strategic planning session, local business expansions and ways BFDC provided assistance to business owners, and status of Railroad project and financing to be returned to Butte County and City of Belle Fourche. Ms. Stalder will provide a link to share with Commissioners. The County was recognized for their work on the Discretionary formula.

Highway Superintendent Dwayne Heidrich presented an activity report including moving of snow, snow blower in use and repair of snow equipment in preparation.

Ordinance 2023-01 Butte County Cattle Guard Policy was presented to commissioners for discussion. Discussion included width requirements, landowner vs County responsibilities for maintenance, replacement, and cleaning cattleguards. Superintendent Heidrich explained reasoning for width requirements and restrictions for maintaining and cleaning cattleguards due to lack of County manpower. Other landowners present were asked for input on the cattle guard maintenance but use them very little compared to the public use of the roads and the concern over expertise required to safely maintain and repair cattle guards as well as closure of roads. Landowners were encouraged to call Highway employees and their commissioner with input.

Motion by Erk to send back for further review. Motion died due to lack of second.

Motion Herman, Second Ager to delay first reading of Ordinance 2023-01 Butte County Cattle Guard Policy until there is more discussion and review. Vote Unanimous. Motion Carried.

State's Attorney LeEllen McCartney presented the State's Attorney office activity report including 2023 grand jury was seated, interviews for interns, and statistics on crimes 2020, 2021, and 2022.

Motion Erk, Second Walton to approve Final Plat – Owner Greg Crow; Lot 1 and Lot 2, A subdivision of the SW4SW4, less Tract A; located in Section 35, T8N, R2E, B.H.M., Butte County, South Dakota. Vote Unanimous. Motion Carried

Director of Planning Donna Jones requested that the commissioners appoint Planning Board member Jim Smeenk as interim board member while applications are sought for a replacement. Commissioner Ager suggested that the County advertise for opening on board.

Ms. Jones introduced Cindy Mayes as new Butte County planner.

Sheriff Lamphere presented an End of Year Activity Report including calls, assists, and revenue for 2022.

Sheriff Lamphere gave an update on Active Shooter Equipment needs for his department. Some purchasing will be done in 2023. Deputies will be attending training and more information on needs will be determined at that time. Equipment purchased by Belle Fourche City Police Department was discussed.

Auditor Capp presented an activity report including status of Levies, 2023 payable tax bills, Department Head meeting, and Annual Report.

Naming Deputies & Clerks

WHEREAS, under SDCL 7-7-20 if in the judgment of the Board of County Commissioners it shall be deemed necessary for the office of County State's Attorney, County Treasurer, County Auditor, Register of Deeds, and Director of Equalization to have deputies or clerks to assist in the daily operations of their offices, and

WHEREAS, the volume and work load of these offices exceed the abilities of one single individual, and

WHEREAS, the Butte County Fiscal Year 2023 Budget has funds allocated for the deputy or clerk positions, and

WHEREAS, the fixed number of deputies or clerks to be employed, the time of employment and compensation which they shall receive must be set,

BE IT THEREFORE RESOLVED, the Butte County Board of Commissioners authorize the County State's Attorney to employ two full full-time deputies, three full-time clerks, the County Auditor's office to employ two full-time deputies, and two full-time clerks, the Register of Deeds

office to employ a full-time deputy, the County Treasurer's office to employ a full-time deputy, three full-time clerks, and the Director of Equalization to employ a full-time deputy, two full-time clerks for the fiscal year 2023 at the compensation rate as established in the Year 2023 Wage Resolution.
