DEPARTMENT HEAD REPORTS:

DOG CONTROL OFFICER: Karen Jaquay was not present but submitted a written report to Supervisor Fogarty. Full details may be viewed in the clerks office or on the town website.

TOWN JUSTICE: Judge Nicholas Rissmeyer reported that \$100.00 was turned over to the Town of Stratford for payment of fines for the month of October.

TOWN CLERK: Patricia Dineen gave the clerks report for the month of October 2022. State, County and Local revenue of \$838.40 of which \$6.00 was submitted to the NYS Ag & Markets spay/neuter program.

CODE ENFORCER: CEO Robert Knapp reported that he attended an eight hour Energy Code Enforcement training class to qualify us for the clean energy program. His full report may be viewed in the clerks office or on the website.

HIGHWAY SUPERINTENDENT: Superintendent Knapp attended an 8 hour snow and ice class at the Fulton County Highway Garage.

The most recent hire on the road crew quit on November 3rd. Superintendent Kanpp is looking for an experienced plow driver to fill the vacancy. Superintendent Knapp's complete report may be viewed at the town clerks office or on the Town website.

SUPERVISOR REPORT: Supervisor Richard Fogarty reported that the next Regional Food Bank will be December 7th, the first Wednesday of each month thereafter.

Supervisor Fogarty received a 3rd Quarter Sales Tax check of \$102,287.24. This is an increase of 15% over last quarter.

Mr. Fogarty again is asking for volunteers to help make plans for the replacement of the gazebo and other improvements that need to be done. Anybody interested please contact Supervisor Fogarty.

The dialing system for the Town Hall Fire System is still waiting for parts.

Supervisor Fogarty announced that he will be changing the brokers for the Town liability insurance and the CDPHP in an effort to save money and achieve better service. He will be moving it to NBT commercial insurances. The actual insurance carrier will remain the same. Only the broker will be changing.

Supervisor Fogarty reminded that there will be a public hearing on November 21, 2022 at 6:30 PM to discuss Resolution #22-2-22 Qualified Abandonment of a Portion of Edick Rd and #23-2022 Qualified Abandonment of a Portion of Hawes Rd.
