Motion seconded by Robin Hartshorn. All voted aye. Motion carried. Jackson Township residents will not incur a tax rate increase from the Township.

2024 Trailer Purchase – Cleveland Brothers (costars) Open Space funds

Robin hartshorn made a motion to approve the purchase of the Base Model – T-16DT S/N N/A Trailer from Cleveland Brothers (costars) with open space funds. Cost of the trailer is \$17,550.00. Motion seconded by Matthew Neeb. All voted aye. Motion carried.

New Business:

Resolution 2024-13: 2025 Tax Milage Rate

Robin Hartshorn made a motion to adopt Resolution 2024-13: 2025 Tax Millage Rate.

Township millage rate:	1.35 mills
Fire millage rate:	.30 mills

Motion seconded by Matthew Neeb. All voted aye. Motion carried. There is no increase in the Township tax millage rates for 2025.

Resolution 2024-14: America250 – PA

Monroe County is organizing celebrations around the 250th anniversary of the signing of the Declaration of Independence. The goal is to celebrate the history of all Monroe County and each municipality in the year leading up to July 4th 2026. Each municipality is encouraged to participate and support by the adoption of a Resolution.

Matthew Neeb made a motion to adopt Resolution 2024-14: America250 - PA. Motion seconded by Robin Hartshorn. All voted aye. In a discussion with Monroe County Commissioner, David Parker, the Township Board of Supervisors were advised the Jackson Township residents will not incur any cost from the Township in the event the Resolution was adopted.
